- 3 **DELIVERY OF REGISTRATION--** I/we agree to (contemporaneously with the execution of this document) (within three days) deliver to (rescue name) Rescue a properly signed transfer of the AKC registration papers for the above described (breed name), omitting the name of the transferee. We hereby designate and authorize (rescue name) Rescue as our agent and attorney-in-fact for purposes of designation a transferee and inserting this name on the AKC registration transfer form.
